Godgal to my will Be it known that James Gardner my son being married to Janet Blain and not behaving himself in a proper way have not left him any cash in my will and Testament but after mature deliberation I hereby leave his proportion of any cash that may be left at both of our decease namely Robert Gardner & Matthew Gardner both sons of James Gardner to be equally divided betwixt the two them not to get the cash till they arrive at twenty one years of age of course at my wifes death & myself are both dead then the two namely Robert and Matthew Gardner will get Interest of this proportion of money till they be twenty one years of age then to be divided betwixt the two. Adie clothier Glasgow and Helen Shanks my Spouse or the survivors or survivor acceptors or acceptor of them the major number surviving and accepting being always a quorum and to their heirs executors and successors whomsoever but that in Trust always for the purposes aftermentioned all and sundry goods gear debts and sums of money household furniture and in general the whole moveable means estate and effects of whatever kind or denomination or wherever situated at present belonging and indebted or which shall belong and be owing to me at the time of my death together with the whole vouchers and instructions of the said debts and other writs and conveyances of my said moveable estate and all that has followed or may be competent to follow thereon and for rendering these presents more effectual I nominate and appoint the said James Thomson James Owen Daniel M. Adie and Helen Shanks and their foresaids to be my sole executors and universal legatories with full power to them to intromit with my whole moveable estate hereby conveyed to give up Inventories thereof and to confirm the same but declaring always that the said James Thomson James Owen Daniel M. Adie and Helen Shanks and their foresaids shall be bound and obliged as by acceptance hereof they bind and oblige themselves as Trustees and Executors foresaid to make payment out of the first and readiest of the means and effects hereby conveyed of all my just and lawful debts death bed and funeral expenses and in the second place my said trustees and executors shall retain and apply the annual rent only or the whole or such part of the remainder of my estate itself for behoof of my foresaid Spouse and such of my children as may continue to reside with her during her life and at the decease of my said
