AT EDINBURGH the Seventh day of October Two thousand and ten the Deed hereinafter reproduced was presented for registration in the Books of the Lords of Council and Session for preservation and is registered in the said Books as follows:-

I, MRS EUPHEMIA SPRATLING, residing at Four Countess Gardens, Crieff, Perthshire, in order to settle the succession to my means and estate after my death HEREBY REVOKE any writings of a testamentary nature heretofore made by me which I authorise my Law Agents to destroy and DO MAKE MY WILL as follows:-

I NOMINATE my nieces MRS ANNETTE MARCELLA MULHEARN, residing at Five Limkilns, Pencaitland, East Lothian, and MRS FIONA GARDENER WILLIAMSON, residing at Thirty Seven Carloverock Court, Tranent, East Lothian, and the survivors and survivor of them to be my Executors or Executor (hereinafter referred to as "my Executors") and I ASSIGN, DISPONE and CONVEY to my Executors the whole means and estate, heritable and moveable, real and personal, of whatever kind and wherever situated that may belong to me or over which I may have power of disposal at the time of my death and I provide as follows:-

(ONE) I direct my Executors to pay my debts, funeral expenses, any Government Taxes and the expenses of executing these presents;

(TWO) I direct my Executors to give effect to any writing signed by me subsequent to the date hereof however informal the same may be provided it clearly expresses my wishes, as to which my Executors shall be the sole judges, and any legacy granted by such writing or otherwise shall be paid and accounted for free of all Government duties exigible therefrom in respect of my death and shall be payable as soon as my Executors consider practicable after my death but without interest;

(THREE) I direct my Executors to pay, convey and make over the residue of my said means and estate equally between and to the survivor of MRS CATHERINE McFADYAN MILLER, residing at Lindean, Peat Road, Muthill, aforesaid, MRS FLORA ALLISON residing at Twenty One Carloverock Terrace, Tranent, East Lothian, GRAHAM MULHEARN, residing at Five Limkilns, Pencaitland, East Lothian, SCOTT MULHEARN residing at Five Limkilns, Pencaitland, East Lothian, MISS KIMBERLY/
